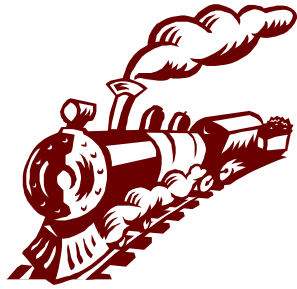

## **BJR Coaches Code of Conduct**

- Head Coaches will commit to their teams and are expected to attend 90% of all practices/games
- Head Coaches commit to these Ethics and Conduct upon accepting the Head Coaching position (verbally or otherwise)
- BJR Player Rep will be active in parent communication and impartial reporting of both positive and negative feedback issues to the BJR Board

Any coach on probation accepts that probationary period is for one calendar year and that failure to act within the required conditions will result in appropriate board action to include removal as head / assistant coach and BJR organization

### Coaching Ethics & Conduct – Brunswick Jr Railroader Football, Cheer, Boys and Girls Lacrosse.

The primary goal of coaches should be the development of players to become better athletes and Citizens. The players must be taught sportsmanship and fair play, and these teachings should always govern their behavior while at practice and at games. Coaches shall be responsible for the conduct of all players, members of the coaching staff and spectators. This includes the time periods before, during and after league games and other events. Improper conduct, in the judgment of the game officials, on the part of the players, coaches or spectators may result in penalties, expulsion and suspension or forfeiture of the game.

- The Coach will focus on player development and game fundamentals at all levels. This is the primary goal of non-competitive levels.
- The Coach will never use negative ridicule or demean children for making a mistake
- The Coach will never use abusive language and/or profanity while representing Brunswick Jr Railroaders
- The Coach will be considerate and reasonable in demands on kids time, energy and enthusiasm.
- The Coach will always operate within the code of conduct, rules and fair spirit of your sport and instruct the kids to do the same.
- The Coach will ensure that the time kids spend with you as coach is a positive experience. All kids are deserving of equal attention and opportunities.
- The coach will avoid overplaying the talented more skillful kids. All kids will have playing opportunities as specified in the BJR Bylaws
- The Coach will Display control, respect and professionalism to all involved within the sport. This includes athletes, opponents, coaches, officials, administrators, the media, parents and other spectators. Encourage players to do the same, be a great role model.
- Where appropriate obtain qualifications and keep up to date with the latest coaching practices and the latest principles of growth and development of children.
- Any physical contact with a child should be appropriate to the situation and necessary for the player's skill development or medical care. At no time will a coach grab a facemask out of frustration.
- The coach shall not be under the influence of alcohol or illegal drugs.
- The coach will accept the decisions of officials during games. Game reports for poor officiating should be submitted to the league after the game.
- The coach will emphasize that good athletes are good students, and both are physically and mentally alert.
- The coach will strive to make every athletic activity serve as a training ground for life and as a basis for good mental and physical health
- The coach will emphasize that winning a game is the result of teamwork
- The coach will refrain from “running up” the score against an opponent. This includes keeping in the first line at all times.
- The coach will set an example in personal conduct at all times while representing Brunswick Jr Railroaders.
- The coach will learn the strengths and weakness of his/her players in order to place them into situations where each has a maximum opportunity to achieve success.
- The coach will protect the health and safety of his/her players by insisting that all of the activities under his/her control be conducted in the best interest of the athlete, rather than the interests of adults – whether parents, coaches or spectators
